# KENT STATE UNIVERSITY HOSTS 20TH ANNUAL STATE OF THE STATE DIVERSITY CONFERENCE



Hundreds of guests from a broad range of institutions and organizations across Ohio will converge on the Kent campus for the 20th annual State of the State: Equity, Opportunity and Diversity in Ohio conference on Thurs., Mar. 17.

The day-long event, titled "Understanding our Past, Embracing Our Future: The Intersections of Identity and Change," will be held in the Student Center Ballroom and bring together professionals from the public, private, nonprofit, educational and corporate sectors pursuing more inclusiveness and representation within their respective organizations and communities.

State of the State is being coordinated by Kent State's Divisions of Human Resources and Diversity, Equity and Inclusion, in cooperation with Bowling Green State University.



John Quinones, an Emmy award-winning co-anchor of the ABC news magazine "Primetime," will serve as the luncheon keynote speaker.

Sonia Manzano will deliver the closing plenary speech. She was twice nominated for an Emmy for her role as Maria in the children's "Sesame Street." She is the recipient of the Congressional Hispanic Caucus Award and the Hispanic Heritage Award for Education.



With nearly a dozen breakout sessions, a few of the conference topics include:

- Title IX investigation
- The Electoral College related to minority voting in presidential elections

The winner of the Reverend Fred L. Shuttlesworth Humanitarian Award will be announced to recognize an individual or organization for actions that advance his legacy. Shuttlesworth (1922-2011), a distinguished Ohioan, played a significant role in the struggle for civil and human rights.

# **Kent State University Welcomes New Employees to Human Resources**

Bonita Prewitt, Gender Equity Compliance Officer/Title IX Coordinator.

Prior to joining Kent State University, Prewitt served as the Director of Equal Employment Opportunity/Affirmative Action at the University of Akron. Her previous responsibilities included Title VII investigations for faculty and staff.

She was also responsible for conducting Title IX investigations and comes to Kent State having already obtained her ATIXA certification for administrators. Ms. Prewitt has also been responsible for the University of Akron's compliance reporting, recruiting of underrepresented candidates, training faculty, staff and students and enhancing performance management for specific areas.

Before that, she was Senior Information Technology Recruiter at Progressive Insurance based in Mayfield Village. Prewitt holds an MBA from Baldwin Wallace University in Berea, and a Bachelor of Science degree from Central State University in Wilberforce, Ohio. Prewitt is a graduate of the Academic Leadership Forum and is certified as a level one and two civil rights and Title IX investigator.

#### April Woodward, Compliance Investigator

Before joining Kent State, Woodward worked as an attorney at Douglas B. Brown & Associates in Chardon, Ohio, where she acquired extensive experience in corporate management-side employment and administrative law. She also specialized in preparing Affirmative Action plans and compliance assistance for government contractors.

Woodward holds a juris doctorate from the University of Akron School of Law, and a Bachelor of Science degree in accounting from Lake Erie College in Painesville.

#### Bobby Brown, Compliance Investigator

Brown most recently taught criminal justice and paralegal studies at Central Georgia Technical College in Warner Robins. Before that, he served as an adjunct professor of general education, business and criminal justice at South Georgia Technical College in Americus.

Brown holds a juris doctorate from the Cleveland Marshall College of Law, a master's degree in public administration and a Bachelor of Arts from Albany State University in Albany, Georgia.

Woodward and Brown will be responsible for investigating formal complaints within a variety of federal regulations, such as Title VII, Title IX, the Americans with Disabilities Act and Affirmative Action.



# OFFICE OF COMPLIANCE, EQUAL OPPORTUNITY AND AFFIRMATIVE ACTION SERVES IMPORTANT PURPOSE

Kent State University has a firm commitment to maintaining a campus environment free from all forms of discrimination and harassment. The mission of the Office of Compliance, Equal Opportunity and Affirmative Action is to ensure equal access to employment and educational opportunities in support of the University's obligation to equal opportunity, affirmative action and diversity. The office is responsible for a host of services listed below:

- Maintaining the University's affirmative action plan, which is a management tool that is used to monitor and address underrepresentation in the University's workforce
- Conduct training and workshops on employment law, the Violence Against Women Act, Title IX laws and regulations
- Reviewing the job applicant pool for faculty, classified and unclassified positions to ensure all applicants are receiving an equal opportunity for open positions



- Process employee and faculty ADA accommodation requests
- Investigate complaints of unlawful discrimination and harassment (Title VII) and gender-based (Title IX) complaints
- To ensure there is a compliance presence, throughout the university, compliance staff members serve on various committees across campus, such as University Diversity Action Council; Americans with Disabilities Act Accessibility; Lesbian, Gay, Bisexual, Transgender and Queer; Sexual Assault Response Team and Human Resources CARES; Pan-African Faculty and Staff Association, Latino Networking Caucus.

Title IX of the federal Education Amendments of 1972 prohibits discrimination on the basis of a person's gender in educational programs or activities operated by recipients of federal funding, such as Kent State.

Many people don't know that Title IX compliance goes far beyond ensuring gender equity in athletics. In fact, it is much broader and protects all students, employees, and visitors to campus from gender discrimination.

Sexual harassment, including sexual misconduct, is a form of gender discrimination and is strictly prohibited by federal and state law, as well as university policy.

The Office of Compliance, Equal Opportunity and Affirmative Action is conducting an ongoing series of customized Title IX trainings for faculty, staff and students.

Facilitator-led trainings are monthly for faculty, staff and students through April.

#### Two classes remain:

- Mar. 23, 9:30 to 10:30 a.m. for faculty/staff, and 11 a.m. to noon for students; and
- April 28, 2 to 3 p.m. for faculty/staff, and 3:30 to 4:30 p.m. for students.

Advance registration is required. Dates are subject to change, or classes may be cancelled if an insufficient number of participants sign up. All sessions will be held at Heer Hall in Room 107. To register visit kent.edu/hr and click on training and development.

### Division of Human Resources Adds "Shred-Mania" to RecycleMania

On March 30, Human Resources will partner with the Office of Sustainability to host Shred-Mania, as part of the RecycleMania competition, on Wed., Mar. 30 from 7:30 a.m. to 1 p.m. at the KSU Ice Arena parking lot.

Shred-Mania is open to all students, faculty, staff and the Kent community. The event allows participants to recycle unwanted documents using a secure, onsite paper destruction service. Materials permitted at Shred-Mania include documents, drawings, photos, blueprints, coupons, tickets, personal checks, magazines, spiral notebooks, hanging folders, paper bags and brochures. It is not necessary to remove paper/binding clips or staples from your documents before shredded. Limit of five boxes per person for Kent community members.



RecycleMania is a friendly competition and benchmarking tool for college and university recycling programs to promote waste-reduction activities to their campus communities. Everyone at Kent State University is eligible to participate in RecycleMania, an eight-week competition to promote waste reduction activities on campus. Held Feb. 7 through Apr. 2, RecycleMania includes weekly office competitions for faculty and staff. The Kent State office or department with the most participation wins a grand prize and bragging rights. Students participate in RecycleMania through the Hall vs. Hall competition and weekly student competitions.

Before shredding Kent State property, staffers must follow university retention periods, complete a record destruction request form and get approval by General Council PRIOR to shredding. #### PERFORMANCE EVALUATIONS ON THE HORIZON



Performance evaluations for classified and unclassified employees will take place from March through June.

Online performance evaluations for classified employees will take place March 21 through May 30. Unclassified employees will conduct evaluation April 4 through June 13.

Managers and supervisors of classified employees will receive an e-mail prior to March 21 with detailed instructions. As a reminder, access is available to the performance log employees and supervisors can use throughout the year to record personal accomplishments, training and discussions.

There are also two webinars available for supervisors and managers.

The first, "Navigating the Online Evaluation Process", will familiarize evaluators with the online assessment tool and will be offered on April 12, from 2 – 3 pm., and again on April

20, from 10 - 11 am.

The second webinar, "Assessing and Improving the Performance of Others", is a webinar for new managers and supervisors offered Apr. 15, 10—11 a.m., and Apr. 25, from 2 - 3 p.m.

performance.





## FlashFit Winter MOVChallenge Leaps into 2016

Open to all full- and part-time faculty and staff, this years FlashFit Winter MOVChallenge spanned 29 days in February.

Fitness goals for the Leap Year contest were simple: Keep moving and have fun! Adding added flexibility, participants were able to use a MOVBand (a wrist-worn monitor) or a number of other third-



party devices or free apps to track daily activity. Those movements and subsequent data were electronically synchronized into the Movable portal. From here, the wellness team was able to send out motivating reminders, communicate weekly winners or throw in a "pop up" challenge throughout the 29-day challenge.

Participants who met the progressively challenging goals were eligible for prize drawings at weekly intervals. The contest was divided into four achievable goals for challengers: 5,000 moves a day for week one, 7,000 moves a day during week two, 9,000 moves a day for week three, and 10,000 moves per day during the last week.

Faculty and staff took full advantage of opportunities to win prizes, including gift cards to Panera, Applebees or Amazon or prizes, such as the new Vivofit fitness band or Fitbit.
