Key Accomplishments:

Achieved a Carnegie Classification rating of R1 (very high research activity) for the first time for Kent State University. Led strategic planning efforts geared toward maintaining R1 status: identified improved and efficient ways to count data involved in R1 criteria, increased efficiency in identifying and tracking research resources, funded a post-doctoral scholar program to support faculty grant success. Oversaw Higher Education Research and Development (HERD) reporting process that resulted in a move of Kent State into the top 200 on the HERD report. Implemented an Arts and Humanities Faculty Fellowship program to improve communication with, and ensure full responsivity to, faculty from these disciplines. Addressed the following key priorities: 1. Supporting research and scholarship in the post-pandemic world - have safely moved to a complete return to research activities; 2. Collaborating with university leadership to ensure financial sustainability of RASP programming and Institutes – successfully negotiated base-budget funding for research institutes, student research programming, and R1

retention efforts; and 3. Negotiated licensing close-out agreements and revised rental agreements with tenants.

Key Accomplishments:

Faced with stay-at-home orders and a shutdown of all but essential research functions due to the COVID pandemic, led a committee of 17 researchers/scholars to develop a phased approach to returning to research labs/studios while keeping the entire KSU family safe. Led multiple information gathering sessions, proposed, defended, and received permission to create five research institutes. Centralized student travel support, large-scale programming and celebrations and developed the Office of Student Research in RASP. Developed the Faculty Research and Innovation Forum Series, a twice-a-semester presentation by three faculty scholars. Launched the Summer Undergraduate Research Experience (SURE) program, providing students with an intensive 8-week residential research experience working one-on-one with the faculty member. Centralized and expanded all research communications by partnering with the School of Media and Journalism, providing opportunities to Journalism students and demonstrating a four-fold increase in numbers of research stories created. Hosted multiple workshops on NIH and NSF funding, foreign threats to the research enterprise, and the impact of COVID on research activities.

This led to my transition into the Associate VPR role in 2015.

Oversaw multiple pilot funding competitions; all with grant submissions as expected return on investment. Served to "matchmake" Kent faculty with individuals at local medical centers to establish inter-institutional research teams. Worked closely with

research counterparts at local medical centers to co-fund and support research teams. Provided workshops to increase the quality of federal grant applications. Signed research agreements with Summa Health System, Akron Children's Hospital, Akron General Hospital and Lerner Research Institute. Provided internal reviews of grant proposals. Oversaw an internal competition in which 30 postdoctoral scholars were provided to KSU faculty from diverse disciplines.
