Shadowing for Kent Salem Diagnostic Medical Sonography Applicants 2024

To familiarize applicants with the role and duties of a sonographer, the sonography program has reinstated the job shadowing requirement. Documentation of **eight (8) hours** of shadowing is required as a part of the application to the sonography program. All eight hours may be completed at a single facility or split between two different facilities, and must be completed by April 1, 2023. Please refer to the attached chart for contact information to schedule shadowing at a Kent-Salem affiliated clinical site. Applicants must adhere to individual hospital requirements for shadowing as listed. Applicants may choose to shadow at a site not listed on the chart, and are then individually responsible for gathering information about and adhering to particular facility's shadowing requirements.

Applicants are strongly encouraged to avoid attempting to schedule these hours in late March, as shadowing opportunities may fill quickly.

Documentation: Take two pages with you to each shadowing experience: the following pages – 2024 JOB SHADOWING DOCUMENTATION (which you will complete and return to Cyndi Peterson after completion of shadowing), and 2024 JOB SHADOWING/OBSERVATION FORM (https://www.kent.edu/columbiana/dms-or-ultrasound) (which you will give to supervising sonographer on the day of shadowing. The facility will fax it to Cyndi Peterson.)

Dress Code: Applicants must dress in a professional manner to include dress/casual pants with a short or long sleeve shirt and appropriate shoes (athletic shoes are acceptable). Applicants must not wear T-shirts, sleeveless or low-cut tops, jeans, shorts, or open toed shoes. There are to be no visible piercings, hoop/dangling earrings, large necklaces or bracelets, no visible tattoos or extreme hair colors. No perfume or scented lotions. Failure to follow the rules may result in cancellation of the shadowing.

Code of Conduct: As a visitor it is expected that the applicant will respect the employees' efforts to conduct themselves as courteous professionals. Although the student experience is observation only, the job shadowing is intended to be an interactive learning process.

HIPAA: All information must be kept confidential to ensure patient privacy by following HIPAA policies.

Cell Phone/Smart Watch/Earbud Use: These devices must be silenced and stowed away during shadowing. The use of electronic devices while shadowing will reflect on your evaluation by the technologist.

Infection Control: Infection control is always important to an applicant's and patient's well-being. Hand hygiene is an important method to prevent infection to the patient and applicant so practice hand hygiene frequently. Masks must be worn if required by facility. Applicants will not participate in any exam of a known COVID-19 patient.

Breakfast: It is recommended that applicants eat breakfast prior to shadowing to prevent light-headedness.



JOB SHADOWING/ OBSERVATION REQUIREMENT - 2024 APPLICATION

Job shadowing /observation is **required** as part of the application process for the Diagnostic Medical Sonography Program at Kent State University Salem Campus. A **minimum of eight hours** must be completed. Shadowing must be completed within twenty-four months preceding submission of the application. No points will be awarded for shadowing exceeding 8 hours. Applicants are strongly encouraged to avoid attempting to complete these hours in March.
