1. Summary

This report provides a statistical analysis of the Kent State University 8-Campus-System enrollment for the Summer III 11 Term. The Kent State University 8-Campus-System experienced a 8.61% increase in unduplicated student headcount; 7,015 students in Summer III 11 compared to 6,459 students in Summer III 10 for a net increase of 556 students. Undergraduate enrollment increased by 12.41% (609 students) and graduate enrollment decreased by 3.42% (-53 students).

Student FTE increase by 5.86%; the Kent State University 8-Campus-System generated 50.94 more FTE compared to Summer III 10. Undergraduate FTE increased by 14.35% (88.03 FTE) and graduate FTE decreased by 14.51% (-37.10 FTE).

The undergraduate mean unit load (MUL) is 1.91 compared to 1.88 in Summer III 10. Graduate MUL is 2.19 compared to last year's 2.47 and the campus MUL is 1.97 compared to 2.02 last year.

Note: During Spring and Fall terms, FTE is the students' total credit hours divided by 15; during Summer terms, FTE is the students' total credit hours divided by 30.
