1. Summary

This report provides a statistical analysis of the Ashtabula Campus enrollment for the Fall 13 Term. The Ashtabula Campus experienced a 6.96% decrease in student headcount; 2,341 students in Fall 13 compared to 2,516 students in Fall 12 for a net decrease of 175 students. Undergraduate enrollment decreased by 6.85% (-172 students) and graduate enrollment decreased by 60% (-3 students).

Student FTE decrease by 10.04%; the Ashtabula Campus generated 135.94 less FTE compared to Fall 12. Undergraduate FTE decreased by 9.99% (-135.14 FTE) and graduate FTE decreased by 57.14% (-0.80 FTE).

The undergraduate mean unit load (MUL) is 7.81 compared to 8.08 in Fall 12. Graduate MUL is 4.50 compared to last year's 4.20 and the campus MUL is 7.80 compared to 8.07 last year.
