1. Summary

This report provides a statistical analysis of the Geauga Campus enrollment for the Summer III 11 Term. The Geauga Campus experienced a 36.71% increase in student headcount; 689 students in Summer III 11 compared to 504 students in Summer III 10 for a net increase of 185 students. Undergraduate enrollment increased by 38.87% (192 students) and graduate enrollment decreased by 70% (-7 students).

Student FTE increase by 37.18%; the Geauga Campus generated 21.33 more FTE compared to Summer III 10. Undergraduate FTE increased by 39.06% (22.00 FTE) and graduate FTE decreased by 64.08% (-0.66 FTE).

The undergraduate mean unit load (MUL) is 1.71 compared to 1.71 in Summer III 10. Graduate MUL is 1.83 compared to last year's 1.55 and the campus MUL is 1.71 compared to 1.71 last year.

Note: During Spring and Fall terms, FTE is the students' total credit hours divided by 15; during Summer terms, FTE is the students' total credit hours divided by 30.
