## 1. Summary

This report provides a statistical analysis of the Salem Campus enrollment for the Summer III 11 Term. The Salem Campus experienced a $18.69 \%$ increase in student headcount; 343 students in Summer III 11 compared to 289 students in Summer III 10 for a net increase of 54 students. Undergraduate enrollment increased by $18.75 \%$ ( 54 students) and graduate enrollment increased by $0 \%$ ( 0 students).
Student FTE increase by $28.23 \%$; the Salem Campus generated 7.50 more FTE compared to Summer III 10. Undergraduate FTE increased by $28.33 \%$ ( 7.50 FTE) and graduate FTE increased by 0\% (0.00 FTE).

The undergraduate mean unit load (MUL) is 1.49 compared to 1.38 in Summer III 10. Graduate MUL is 1.50 compared to last year's 1.50 and the campus MUL is 1.49 compared to 1.38 last year

Note: During Spring and Fall terms, FTE is the students' total credit hours divided by 15 ; during Summer terms, FTE is the students' total credit hours divided by 30 .
