Explain the purpose for this proposal:

The purpose of this proposal is to establish a new course. The purpose of the course is to provide students with an opportunity to participate in a course with like minded peers who are attending college for the first time. Students will quickly understand that attending college classes require self-motivation and commitment to meet course expectations and requirements. Students must be able to manage their time and daily lives in a way that they have never had to before. Students will be challenged to examine their values and beliefs, and to realize the importance of developing self-determined behaviors and responsibility for their academic career. Learning Outcomes: 1. The student will develop skills that help them to become more professional in their work. 2. The student will develop critically thinking and self-reflection skills in order to evaluate themselves and their work. 3. The student will know of the resources and opportunities available to them on campus. 4. The student will become more self-determined and more independent as they begin their college career. 5. The student will understand the importance of setting and attaining academic goals. In Class Activities: 1. Participating in class and small group discussions of what it means to be in college. 2. Practicing writing and critical thinking skills through various assignments that challenge the student to become more self-aware of personal attributes. 3. Reading articles and other course requirements in order to broaden ones thinking. 4. Attending EHHS MajorsMinors Fair and completing assignments in order to identify possible career options. 5. Attending an Academic Advising appointment with advisor. 6. Participating in the final group project or portfolio. 7. Completing an academic study plan with advisor. 8. Attending activities at the Welcome Weekend. Out Of Class Activities: This course will have various assignments to be completed outside of the classroom. These assignments include: readings, written work, and hands-on activities pertaining

CCS students enrolled in this course will attend sessions of the Kent State course US 10097 Destination Kent State: First Year Experience, Per agreement with the various colleges, CCS faculty will provide support to the CCS student and KSU faculty as the student participates in this inclusion setting, and CCS faculty will provide academic mentoring as the student completes assignments. CCS is a non-degree program and students will receive a SU for their participation in the classroom.

Explain the purpose for this proposal:

The purpose of the proposal is to establish a new course. The purpose of the course is for students to learn how to organize thoughts and materials into concise and easily understood information that can be communicated effectively to others. Effective speech making involves knowing the subject and feeling passionate about the topic so that one can connect to the audience to get key points across. The skills used in developing, researching, organizing, critically reflecting, and delivering well planned speeches can be applied to all areas of a person's life. Students gain confidence in abilities to relay meaningful information that will help them to vocalize their feelings, and thoughts, and as they self-advocate for their goals and support needs. Learning Outcomes: 1. The student will develop and understanding of selected interpersonal, group, and public communication theories and how they may be applied. 2. The student will understand the elements of ethical communication. 3. The student will demonstrate effective and professional-looking presentations. In Class Activities: 1. Completing online weekly quizzes. 2. Completing online midterm and final exams. 3. Participating in weekly in-class small group activities such as responding to questions, completing a survey, working on a component of a speech. 4. Organizing an outline of speech topics using appropriate APA formatting when necessary. 5. Creating an informative, persuasive, and group speech. 6. Completing a self-critique on each speech given. 7. Designing quality PowerPoint or Prezi presentations used for the speech. 8. Participating in communication research projects. Out Of Class Activities: All courses will have various assignments to be completed outside of the classroom. These assignments include: readings, written work, and hands-on activities pertaining to the weekly topics which are to be practiced before the next class meeting.
