FLA-RPTM Articulation Agreement with Lakeland Community College; Phillip Wang	Proposal establishes a 2 + 2 articulation agreement between RPTM and Lakeland Community College for its AAB degree in Business Management (Parks and Recreation Management concentration); program credit hours are 121; effective Spring 2011. Wang shared that this articulation agreement is endorsed by RPTM faculty and that establishing equivalencies was a major part of this agreement. The agreement is expected to bring 10+ new students to KSU annually.	Motion to approve proposal by Averil McClelland; seconded by Davison Mupinga; approved by unanimous vote.
HS-EXSI Articulation Agreement with Cuyahoga Community College; Ellen Glickman	Proposal establishes a 2 + 2 articulation agreement between EXSI and Cuyahoga Community College for its AAAS degree in Sport and Exercise Sciences; program credit hours are 121; effective Spring 2011. This agreement is supported by faculty and Provost's office and is expected to bring between 5 and 10 new students per year to KSU.	Motion to approve proposal by Angela Ridgel; seconded by Belinda Zimmerman; approved by unanimous vote.
