Mr. Beckwith - responding to your concerns. The issues that you raise are well taken. Your

input will reinforce our findings and recommendations of the master plan.

Please reconfirm the actual number of aircraft that you operate out of KSU airport and also the actual number of aircraft that you would relocate from Akron Canton airport to KSU or a nearby site if proper facilities were available. Also if you could categorize the fleet mix into types of aircraft; i.e. how many aircraft with wingspan less than 49-ft and approach speed less than 91-knots; and how many aircraft with wing span more than 49-ft but less than 79-ft and approach speed more than 91-knots but less than 121-knots. Also a break down into propeller and turbo/jet would be helpful.

Regarding your question for documentation of transient aircraft; the records are taken when the airport is staffed. However we have put out permanent counters on a 24/7 basis for ten weeks and subtracted the based operations from that data. The accuracy of the data is +/-

10%.

Regarding your "Wish List" our recommendations are as shown on the future/ultimate airport lay out plan and the detailed listings in the master plan report. Our facilities recommendations are determined by forecast based and itinerant aircraft and operations and the associated demands and plannig standards. The forecasts are based on market share/dynamic. We believe the accuracy of the forecasts to be +/- 5%. All fundamental indicators are positive and there is no credible data available to us to consider forecasting a static/no growth curve. In addition there is a trend by businesses towards fractional ownership, shared flight services etc. Further carrier airports with backlogs during peak periods have no options but to discourage small business type and recreational use of aircraft within their airspace and encourage the use of less congested airspace i.e. GA airports. At the moment our slower than expected, progress is due to our inability to convey our findings acceptably to the public and public officials. In short schrift we prefere not to use the TAF data when all indicators flow in the opposite directions. We encourage all recepients of this e-mail to critique the master plan from their point of view. Respectfully Hermann.

Kim Thank you for your comments regarding the Airport Master Plan. Your comments will become part of the public record.

As discussed at the meeting last evening Richland Engineering is researching impact onto property values as a result of expansion and we will report the finding at the next pubic meeting.

Regarding your comment on taxes to Stow. I tried to be clear in the meeting that this was the direct tax benefit to Stow, ie, payroll tax, etc. There are economic benefits that do result to the community beyond this direct income tax.

Regarding your comment on relocation to a more rural area. The purpose of the alternative analysis is to find the best approach to meet future aviation demand and balance the interest of the communities regarding economic, social, and environmental impacts. Dear Mr. Clapper,

I have a couple questions regarding the airport master plan and KSU's plan to close the facility. I'm hoping you can shed some light on these and I would much appreciate a reply.

The master plan projects an increase in demand at the airport such that a runway extension is needed. The apparent need for expansion is at the heart of the argument for closing the airport. However, senior members of the Aeronautics program at the university, including Department Chair Dr. Isaac Nettey, Richard Clark, and Tim Palcho have commented that they see absolutely no need to lengthen the runway. I would consider these people experts in their field who can competently speak for the KSU academic flight training program. Also, in the past several months I, myself a pilot, have spoken and corresponded via e-mail with over one hundred local pilots. Not one of them has felt a need to lengthen the almost 4,000 ft. runway. Therefore, my first question is, what facts have lead you to believe that the runway must be lengthened?

Second, I have heard the claim that the university can get \$300 million by selling the airport land for development. With less than 300 acres of land, that comes to over \$100,000 an acre. To date, I am not aware of any land in or around the city of Stow that has sold for more than \$30,000 per acre. My second question then is, by what basis does the university expect to get over \$100,000 per acre for this land?

Thank you in advance for your consideration of these questions.

Dennis,

I have lived in the Munroe Falls area a little more than 5 years. My residence is in the River Park Estates which finds itself somewhat close to the end of your runway.

During these years, there have been a number of occasions where it was my perception that a pilot was following unsafe practices. On more than one occasion, you called me at my home to discuss my concerns. And, on each instance, it was my perception that the matter was properly addressed.

In other words, the Kent Airport has shown itself to be a responsible neighbor.

With that thought in mind, I naturally assumed that our good neighbor would

have its consultant contact us if possible expansion plan alternatives

have an impact on our residence. After all, that is what a RESPONSIBLE consultant does. A responsible consultant checks with both his client and customers (in this case the community).

During last night's informational meeting the following became clear. This consulting team failed to contact:

* Stow council: A number of Stow council members stood up last night and indicated that they had never been contacted with any of the proposed alternatives.

* The community: This concern was mirrored by a number of residents of the Stow and Munroe Falls area. I share this concern. I have never been contacted about such plans.

 Stow Munroe Falls School systems: Reports indicate that key leaders

have not been contacted.

Imagine my shock last night when I discovered that two of the alternatives (fortunately tabled at this time) would have taken our house away from us. This is the same house used by my wife and I to raise our three young children.

In other words, one has to wonder about the true benefit analysis of this study. One begins to wonder if the consulting team is more interested with its earnings and the immediate client, period. This, in my opinion, is NOT the representation that Kent State University needs. A responsible neighbor

will take the time to hear its residents complaints "completely" and then choose an action which BEST meets the needs of both the University and community. This does not seem to be the case at this time.

Kent State has an opportunity to salvage this issue. First, the next proposed community meeting should have Board Members present. I am not sure our consulting group can be trusted to report how the public really feels about this issue. Next, if would go far if the public were invited to an OPEN discussion on this topic when the board holds its next board meeting. Finally, the community made it clear that they like their neighbor; they simply hope future plans do not diminish the excellent community which has developed over time.

As a resident of Stow I would prefer to have the airport remain and continue to operate as a General Aviation airport rather than have the property turned into houses, strip malls and 'light industry'. The increase in population and the traffic accompanying more houses would bring about a lowering of the quality of life to Stow and the surrounding communities. One only has to drive down Commerce Road to see how many 'light industry' business have left the area. Since I moved into Stow to practice medicine in 1991, I have noticed a decrease in the quality of life due to the increase in traffic along the major roads that cross through Stow. Despite the increase in population of Stow, I have not seen any improvement in services that I would expect to see with the increase in tax revenue. The traffic along Graham Road, Kent Road, Darrow Road and Fishcreek Road has made it impossible to safely ride my bicycle from one bike path to another. My house is in the Willowdale development

that backs up to Darrow Road. The airplanes that land on Runway 1 (one) at Kent State airport follow Darrow Road South to the airport. The noise that they create is drowned out by the noise that is generated by the traffic on Darrow Road. The volume of traffic and the speeds that they drive at, is such that at times during the day it is difficult to safely exit my development and for my patients to leave my former office (at 4465 Darrow Road). I have been woken at night by cars on Darrow Road playing their radios at obscenely loud levels, never by an airplane en-route to the airport. Adding more houses at the site of the airport will not improve this situation. Keeping the space open, as a public use airport will provide a buffer zone between the residential and business areas of Kent Road.

As a pilot who uses Kent State Airport, I would like to see the airport brought up to current standards of safety. This improvement to the physical plant of the airport as well as the excellent training that the pilots receive from the KSU aviation program will help keep the airport the safest in the state and a good neighbor to the people of Stow.

On a person note, I go to the airport at various times of the day and evening to enjoy to peace and quiet that it offers when the operations are at a lull. The view of the sky and the countryside from the bench that is available at the bus stop at the airport is truly a gift that the residents of Stow need to experience before it is lost to uncheck development in Stow.

They, however, were nothing compared to that train I heard every night. The trains really bothered me. I moved out of Stow and have lived in Cuyahoga Falls ever since.

I guess what I'm trying to say is: instead of closing the airport, you should stop allowing trains to go through town. In addition, cars should not be allowed to have their motor running after sunset. Does that sound ridiculous? Well, I think closing the airport sounds ridiculous. While we are on the subject of ridiculous, I graduated from the flight program at Kent. Currently, I am up to my neck in student loans from all those flight fees and raised tuition. When I started school at Kent 3 years ago, I thought the campus was disgusting. In the past year, I will say it looks a lot better. However, the airport is still a dump. I am a flight instructor at the airport now. I have students who drive down the street to use the restroom because the airport's facilities are so nasty. They are not dirty by any means; the staff does an excellent job of maintaining them. There is not much to work with though. Back to the ridiculous subject, I think it's ridiculous that the students pay

ing the most for their education (flight students) have the WORST facilities. I guess its because there is no money to for improvements.

I work long hours at the airport. It's how I make a living. I only wish I had the money to build an expensive house next to an airport that had been there for years. I wonder what I will do if the airport closes. I will be out of a job. The airline industry is not all that good right now. I do not have the experience to get an airline job yet anyway. There are not many jobs for flight instructors either. Maybe I will have to give up what I worked so hard for and take on a new field. Maybe I should give up what I love doing so a man with more money than I'll ever see can have the perfect life. I remember when I first visited the University. They told my tour group that the University worked hard to find jobs for their graduates. I was torn between two schools at the time. I think that was what finally made me choose Kent. So why is the University trying to take my job from me? Since they didn't hold up their end of the bargain, does that mean they will pay off the \$70 thousand

in student loans I owe?

We use aircraft and infrared technology to view heat loss and leak areas on flat roofs to save the local businesses, schools, that have large roof areas a tremendous amount of money in cost savings of repairing the roofs, instead of having to replace these roofs prematurely. Large flat roofs with steel decks have channels that allows water to travel as little as 10 feet, to as much as 100 feet away from the actual hole in the roof.

To lose the services, availability, and the conveinience of the local airport would cost the local community thousands per year in additional costs of having to travel to Wadsworth where my plane is hangared. If anything, more privately owned hangar space would be a boon to the local community as there are many aircraft owners and pilots that travel to other towns and cities and pay taxes and costs there instead of here.

The Kent State newspaper has reported that the university plans to close its airport in Stow (1G3) as a result of its current Master Plan.

It is my sincere hope that you will not allow this to happen. 1G3 is federally obligated. KSU last accepted federal dollars in 1998. My understanding is that airports are committed to staying open for 20 years after accepting grant funds.

In addition to the university's obligation to the aviation community, 1G3 is historically significant. The airport was built in 1917 and served in WWI and WWII by training fighter pilots. Notable aviators such as Eddie Rickenbacker have flown out of the airport.

Stow Mayor Karen Fritschel and the Stow City Council have gone on the record that a vast majority of Stow residents favor the airport staying. There are a few people who recently built million dollar homes just off the end of the runway who are now complaining. These people do not represent the majority!

Again, it is my hope that the FAA will hold the university to its obligation to keep the airport open at least until 2018.

I have observed with interest the events surrounding the future disposition of the KSU Airport. I am an aircraft owner and pilot residing in the greater Akron area for over 25 years. In the early 1980's my own aircraft was based at KSU when it was more geographically suitable for my needs. Smaller aircraft, whether used for business or pleasure are time-saving travel machines. The amount of time saved by flying is directly impacted by the convenience of an airport to its end users, whether it is their departure or destination point.

I have read the accounts in the newspapers (including the KSU publication), and I have also read the letter recently sent to you by the Aircraft Owners and Pilots Association. This leads me to believe that I understand many of the issues at hand.

As a long-time developer of commercial real estate, I can speak with some authority as to the difficulties encountered in gaining all the necessary approvals for developing larger tracts of land. Even for rather benign commercial uses, finding a properly located larger land parcel and then clearing all the bureaucratic hurdles of pre-development can be a daunting task in today's environment. An existing airport, no matter its size, is a valuable community asset that once lost is logistically next to impossible to replace. The task of finding an acceptable, convenient location and then gaining the approvals to develop a new airport within feasible economic guidelines is practically insurmountable. As a non-aviation comparison, imagine the impact of closing SR 43 and then forcing all traffic into Kent via alternate routes. Not only would the traffic flow be less efficient, but it undoubtedly, would give rise to complaints from those living along the replacement routes who would find the increased traffic volumes very undesirable. And can you imagine the time line and cost to design, secure the land, engineer, and build an appropriate replacement route for a major artery such as SR 43? Now imagine the task of replacing an airport which would be a substantially more difficult undertaking. that reason alone, we cannot arbitrarily view these physical assets as "disposable".

The potential loss of the KSU Airport will also serve to transfer its nearly 200 daily operations to other nearby airport facilities. This may ultimately give rise to safety, capacity, and noise issues at those other airports as the air traffic suddenly increases. Notwithstanding, complaints from residential neighbors of an airport must be taken in context. I am completely confident that the KSU Airport existed long prior to the development of many of the homes whose owners are now the source of complaints. To move in proximity to a long-existing airport and then complain about air traffic is tantamount to buying an oceanfront home and then complaining that the salt air corrodes the home's metal hardware. The issue is obvious and should be known and considered in advance of making the decision to purchase.

I do concur with AOPA in stating no opposition if the University wishes to relocate its aviation education programs to another facility. At the same time, I must encourage you to take all necessary measures to maintain the existence of this valuable and irreplaceable airport facility even with its current runway dimensions.
