# FIFTEENTH DAY ENROLLMENT STATISTICS

**Kent State University 8-Campus-System** 

Summer I&II 12

### 1. Summary

This report provides a statistical analysis of the Kent State University 8-Campus-System enrollment for the Summer I&II 12 Term. The Kent State University 8-Campus-System experienced a 1.77% decrease in unduplicated student headcount; 12,520 students in Summer I&II 12 compared to 12,745 students in Summer I&II 11 for a net decrease of 225 students. Undergraduate enrollment decreased by 2.98% (-289 students) and graduate enrollment increased by 2.10% (64 students).

Student FTE increase by 1.84%; the Kent State University 8-Campus-System generated 39.97 more FTE compared to Summer I&II 11. Undergraduate FTE decreased by 0.76% (-12.06 FTE) and graduate FTE increased by 8.97% (52.03 FTE).

The undergraduate mean unit load (MUL) is 2.52 compared to 2.46 in Summer I&II 11. Graduate MUL is 3.05 compared to last year's 2.86 and the campus MUL is 2.65 compared to 2.56 last year.

Note: During Spring and Fall terms, FTE is the students' total credit hours divided by 15; during Summer terms, FTE is the students' total credit hours divided by 30.

For example, if a student has six hours at the Kent Campus and three hours at the Stark Campus, the student would be counted once at the Kent Campus and then once at the Stark Campus. Headcount for each campus in this table is concurrent.
