1. Summary

This report provides a statistical analysis of the Ashtabula Campus enrollment for the Spring 13 Term. The Ashtabula Campus experienced a 1.55% increase in student headcount; 2,614 students in Spring 13 compared to 2,574 students in Spring 12 for a net increase of 40 students. Undergraduate enrollment increased by 1.63% (42 students) and graduate enrollment decreased by 50% (-2 students).

Student FTE decrease by 0.28%; the Ashtabula Campus generated 3.73 less FTE compared to Spring 12. Undergraduate FTE decreased by 0.25% (-3.27 FTE) and graduate FTE decreased by 63.01% (-0.46 FTE).

The undergraduate mean unit load (MUL) is 7.56 compared to 7.70 in Spring 12. Graduate MUL is 2.00 compared to last year's 2.75 and the campus MUL is 7.55 compared to 7.69 last year.
