1. Summary

This report provides a statistical analysis of the Trumbull Campus enrollment for the Fall 09 Term. The Trumbull Campus experienced a 27.45% increase in student headcount; 2623 students in Fall 09 compared to 2058 students in Fall 08 for a net increase of 565 students. Undergraduate enrollment increased by 28.33% (578 students) and graduate enrollment decreased by 72.22% (-13 students).

Student FTE increase by 25.59%; the Trumbull Campus generated 332.26 more FTE compared to Fall 08. Undergraduate FTE increased by 25.90% (335.26 FTE) and graduate FTE decreased by 75% (-3.00 FTE).

The undergraduate mean unit load (MUL) is 9.34 compared to 9.52 in Fall 08. Graduate MUL is 3.0 compared to last year's 3.33 and the campus MUL is 9.33 compared to 9.46 last year.
