2019 Summer and 2019-2020 Academic Year Research and Creative Activity Appointments

DEADLINE: October 1 at 5 p.m.

The next internal grant competition is the University Research Council's Summer and Academic Year Research and Creative Activity Appointments. The deadline is Monday, October 1 at 5 p.m. Summer appointments have a stipend of (to be determined) for a 10-week period, and academic year appointments provide the equivalent of one semester of research time at regular salary, which may be spread over one semester (Fall or Spring) or both Fall and Spring semesters. 




Award rates for grants submitted by Kent State University at Stark faculty members in internal Kent State University grant competitions declined in fiscal year* (FY) 2018 from FY 2017, which was a record year in both number and dollar awards of internal grants. The award rate represents the number or dollar value of grants awarded as a percentage of the number or dollar value of grants submitted. The award rate for the number of internal grants was 59% in FY 2018 compared with 62% in 2017. (Figure 1) Faculty received approximately 3 out of every 5 grants for which they applied internally. For the dollar value of internal grants, the award rate was 19% in FY 2018, compared to 52% in FY 2017 and a three-year high of 17% from 2014 to 2016. Another way to consider the dollar award rate is that for every dollar requested in 2018, Kent State Stark faculty members received 19 cents.

Figure 2 displays the total number of internal grant competition submissions and awards by Kent State Stark faculty from fiscal year 2014 to 2018. In 2018 Kent State Stark faculty submitted 32 internal grants, an increase from FY 2017, and were awarded 19, the highest number of awards from 2014 to 2018.

The total dollar value of internal grant submissions and awards by Kent State Stark faculty from 2014 to 2018 is displayed in Figure 3. Kent State Stark faculty submitted grant proposals requesting \$292,303, and were awarded \$55,252 in FY 2018.

Kent State Stark Grant Activity Update

Grant Activity by Quarter, Fiscal Years 2017 – 2019

Table 1 displays grant submissions by quarter and outcomes and award rates for the corresponding quarterly grant submissions. The Stark Campus closed out fiscal year (FY) 2018 with a revised 63 grant submissions valued at \$1.6 million, compared to 61 submissions in FY 2017 valued at \$5 million. FY 2018 notifications will not be closed out until we are notified of all grants submitted in FY 2018 (in November 2018).

In FY 2018, 38 grants have been awarded to date, valued at \$451 thousand with 2 grants outstanding valued at \$33,195, which compares to 31 awards valued at \$1.1 million in FY 2017. Kent State Stark currently has a 62% award rate based on the number of proposals for FY 2018 and a 29% award rate based on the dollar value, compared to 51% and 23%, respectively, in FY 2017.

In the first quarter of FY 2019, one grant valued at \$100,000 has been submitted to date.

Sloan Foundation, <u>Public Understanding of Science, Technology, and Economics</u>, primary aim is to build bridges between cultures of science and humanities and develop a common language so that they can better understand and speak to one another; nationwide strategy focuses on books, theater, film, TV, radio, and new media to commission, develop, produce, and distribute new work mainstreaming science and technology for the lay public, letter of inquiry is first step.
