Schedules and oversees external environmental audits of the plant and provides direction and assistance to maintenance and operating departments. Has significant influence on regulatory compliance, environmental policy and internal management standards for environmental programs for both the Dover, OH and the Hammond, IN facilities. Assesses the impact of regulatory changes that impact operations to ensure compliance. Required to keep abreast of new environmental regulatory requirements.
