History of Celebrating College Teaching

In 1992, Kent State University's Collective Bargaining agreement developed provisions for the support of teaching. Those provisions ultimately led to the establishment of the University Teaching Council (UTC). A contractually initiated committee to study faculty professional development (Faculty Professional Development Study Committee) wrote the enabling legislation for the UTC and guided it through the Faculty Senate. The study committee was composed of six people (two Faculty Senate representatives: Mary Lou Holly, Ph.D.; Jerry M. Lewis, Ph.D.; two administrators: Larry Andrews, Ph.D., and Thomas J. Barber, Ph.D., and two association members: Stephane Booth, Ph.D., and Michael Lee, Ph.D.).

The enabling legislation for the University Teaching Council was modeled on the structure of the University Research Council (URC). Parity with the URC in the form of financial support was sought. Although that parity was not obtained, provisions for additional kinds of grants (for travel, for learning and summer teaching projects among others) were designed. These included provisions for curriculum development as a key area for support as it relates to teaching and an annual conference to help build a community around the scholarship of teaching. Thus, the Celebrating College Teaching Conference was designed to identify, recognize, promote and celebrate the many positive teaching-related activities going on at Kent State.

Rick Vardaris, Ph.D., psychology, chaired the Conference Committee for the first three years, stepping down in 1995. Lewis chaired from October 1995 to July 1996 and then stepped down when he formally retired. Steve Zapytowski, theatre, served as chair from 1996 to 2000. Bruce Friesen, Ph.D., sociology, Kent State University at Stark, served from 2001 to 2004; in 2005, Kimberly Peer, Ed.D., School of Health Sciences, assumed the chairship.

The conference initially involved committee members meeting with a keynote speaker on Saturday morning, but this was soon curtailed for pragmatic reasons. However, some significant components were added as the conference matured. These included linking the conference to the Thursday night Read Lecture and awarding the Distinguished Teaching Awards (full-time faculty) and the Outstanding Teaching Awards (full- and part-time nontenure track faculty) at the conference as of 1995. Campus Conversations — a chance for colleagues from different disciplines and campuses to actively talk together about teaching — was added in 1999, as was a reception for new faculty as a means to introduce them into a campus culture which values teaching. Graduate's Applause (now Faculty Recognition) was added at the 2000 Conference. In 2001, the Read Foundation brought in a Friday morning keynote speaker instead of having a separate event on Thursday evening. The Provost's Office inaugurated the Thursday night Provost's Emeriti Lecture in 2002. In 2007 Round-table discussions were added to the Provost's Breakfast. The Faculty Professional Development Center first hosted the pre-conference workshop in 2011. In 2013, a Thursday faculty dialogue was added. In 2016 the Emeriti Inspirations were given at the Provost's Breakfast. The conference transitioned to a one-day event in 2017.

Celebrating good teaching continues as the major thrust of the conference, which celebrates its 24th anniversary this year.

Judy Oslin, "Living the Curriculum: Part II"



Judy Oslin, Ph.D., is Professor Emerita of Physical Education, with the School of Exercise, Leisure and Sport. Dr. Oslin retired from Kent State in 2007 after 32 years of teaching, including nine as a public school teacher. Prior to her 16-year tenure with Kent State, she was an assistant professor at the University of Alabama, Tuscaloosa. She had numerous publications, over 100 national and international workshops and presentations, and was co-author of three textbooks.

Dr. Oslin received her B.S. and MA. From Kent State University and her doctorate from The Ohio State University.

After retiring, Dr. Oslin taught courses at the University of the West Indies, Trinidad/ Tobago; served as a visiting professor at the University of Limerick, Ireland; and was a guest lecturer at the University of Castilla-La Mancha, Ciudad Real, Spain. Now, as a fulltime retiree Judy enjoys golfing, biking, hiking and traveling with her partner, Connie.

Jerry M. Lewis and Lisa Waite, "To Pun or Not to Pun: That Is the Question" Moderator: Jennifer Marcinkiewicz



Emeritus Professor of Sociology **Jerry M. Lewis**, Ph.D., was among the members of the Faculty Professional Development Study Committee that wrote the enabling legislation that led to the creation of the University Teaching Council and the provision for the Celebrating College Teaching conference. Dr. Lewis chaired the conference planning committee from October 1995 to July 1996, when he stepped down after formally retiring. Always a strong supporter of the conference, he continued to serve on the committee as emeritus representative for many years. In 2009, he presented the Glenn Frank Lecture.

Throughout his academic career, Dr. Lewis taught such diverse courses as Contemporary Social Theory, Sociology of Sport, Teaching Sociology and Sociology of Religion. His excellence in teaching has been recognized many times. In '70, '81, '82 and '83 he was selected as one of Kent State's Ten Outstanding Teachers. In 1983, he received the Distinguished Teaching Award.

Dr. Lewis received his B.A. from Cornell College, Mt. Vernon, Iowa, M.S. from Boston University and Ph.D. from the University of Illinois (Urbana).



Lisa Waite

Lisa Waite, an associate lecturer in the School of Communication Studies, has a passion for teaching and learning. She has 25 years of experience teaching all levels of university undergraduate communication courses; directing Communication Practicum and Internship field experiences; serving as interim coordinator; developing service-learning experiences and new courses; and advising students. Ms. Waite is a dynamic speaker, and her presentations at this conference in 2006 and 2010 were well-received.

Her professional affiliations include American Association of University Professors (AAUP), American Society of Training and Development (ASTD), National Association of Professional Women (NAPW) and National Communication Association (NCA).

She earned her master's degree in communications from The University of Akron. She holds master certifier status in advanced organizational communication from Barry-Wehmiller University.

Jennifer Marcinkiewicz, Ph.D., is director for the Center for Teaching and Learning and associate professor with the Department of Biological Sciences at Kent State University. In the Department of Biological Sciences, she serves as coordinator of the Integrated Life Sciences program and co-director of the Upward Bound Math-Science program.

Dr. Marcinkiewicz earned her Ph.D., master's and bachelor's degrees in animal sciences from the University of Illinois.

Robin Joynes, "Finding the 'Signal' Amidst the 'Noise'"



Robin Joynes, Ph.D., is an associate professor with Kent State University's Department of Psychological Sciences. Dr. Joynes became a faculty member at Kent State in 2000; prior to that, she served a post-doctoral fellowship at UCLA.

Dr. Joynes was honored with a 2013 Outstanding Teaching Award. She also received the Distinguished Teaching Award for Arts and Sciences in 2006 and a recognition award from Student Accessibility Services in 2012.

Her students describe her as a compassionate teacher, one who is able to make the class laugh and still maintain a serious learning environment. She says that she is finding more and more effective ways to engage her students. Every year, she sees grades and attendance go up. "I feel like I'm raising the bar, and the students are rising to this bar," she says. "They are looking at the material in ways I would never consider, so I get to spend as much time being a student as I do being a teacher. When students can look back and say that they learned a lot and were taught effectively, that's what is most rewarding," Dr. Joynes says.

She received her Ph.D. from Texas A&M University in experimental psychology.

This year marks the 51st class of the Distinguished Teaching Award recipients and finalists.

Distinguished Teaching Award Recipients:



Gary Koski, Department of Biological Sciences, Kent Campus

Gary Koski, Ph.D., associate professor, shares that he tries to provide real value to his students knowing that they pay a lot of money in order to attend college. He states that capturing student interest is the single most important aspect of teaching.

"I try to impress upon my students that 'science' is not simply a set of ossified facts, but a dynamic, critical process," Dr. Koski says. "Furthermore, our understanding is not only constantly evolving, but great advances are made by real people, often in the face of incredible resistance."



Zhiqiang Wang, Department of Chemistry and Biochemistry, Kent State University at Geauga

Zhiqiang Wang, Ph.D., associate professor of chemistry, is able to create, with her teaching, an academic environment that promotes the intellectual and professional development of students by preparing them for employment or graduate school and inspiring them to learn and discover.

Dr. Wang says that over the years she has strived to make a difference and educate students to become critical thinkers, readers and writers. She describes herself as a reflective teacher who knows that there's always room for improvement.



Robin Vande Zande, School of Art, Kent Campus

Robin Vande Zande, Ph.D., associate professor, describes how her teaching and research are intertwined. Her research area is design thinking, a creative and collaborative approach to problem solving, which offers a unique model for educators.

Dr. Vande Zande says that preparing students to use design and teach design thinking is giving them life skills.

Richard Mangrum, College of Aeronautics and Engineering, Kent Campus

Richard Mangrum, Ed.D., professor and Graduate Program coordinator, focuses his teaching on guiding students to help achieve their goals. During his classes, he asks himself, "Would I be okay with these students flying, controlling and managing a flight with my family on board?" Dr. Mangrum continues to remain qualified and relevant in the aeronautics industry in order to educate students to take part in the global industry of transporting goods and people. He believes his teaching must facilitate an environment that produces capable, competent and critical thinking professionals to ensure only well-qualified people graduate.



Rochelle Hostler, School of Teaching, Learning and Curriculum Studies, Kent Campus

As **Rochelle Hostler**, lecturer in teaching, learning and curriculum studies, prepares to meet a new group of pre-service teachers each semester at Kent State, she strives to model for students the dispositions she expects them to enact when working with young children. Ms. Hostler does this by being clear, organized and honest, and by demonstrating a commitment to both student learning and to the field of early childhood. Her proudest teaching moments are those where students are able to articulate their understanding of the ways that their teaching practice can influence a child's life at school.

Lecturer **Ellen P. Daniels**, created the Professional Sales Certificate program in 2013, the only professional certificate offered within the College of Business Administration.
